# SPECIAL TERMS AND CONDITIONS

### for Yearly Promo Student Membership

#### **ARTICLE I - RECITALS**

- 1. The subject of these Special Terms and Conditions is the regulation of mutual rights and obligations between H.O.L.S. d.o.o., with the registered office at Slavonska avenija 6, Zagreb, entered into the register of Commercial Court in Zagreb under registration No. 080049755, PIN: 23971298808 (hereinafter referred to as the "Company"), and the Member concluding the Agreement (as respectively defined in the General Terms and Conditions) with the Company for Yearly Promo Student Membership in the period from 15 October 2025 to 15 November 2025.
- 2. General Terms and Conditions apply to all matters not regulated in these Special Terms and Conditions, unless a particular provision of the General Terms and Conditions is expressly excluded or in collision with the provisions of these Special Terms and Conditions. In the case of any discrepancy between the General Terms and Conditions and these Special terms and Conditions, the Special Terms and Conditions shall prevail. Terms beginning with a capital letter have the meaning assigned to them in the General Terms and Conditions.

#### ARTICLE II – TYPES OF MEMBERSHIP

- 1. Apart from the types of Membership set out in the General Terms and Conditions, these Special Terms and Conditions introduce an additional type:
- A. Yearly Promo Student Membership > A Member who enters into a written Agreement for a fixed period of 12 (twelve) months and proves that is enrolled as a university student for the current academic year, for example by presenting the student card, will be entitled to use the Services of all Clubs throughout their opening hours in accordance with the Visiting Rules of the particular Club, provided that the Member has paid the Membership Fee for the entire term of the Membership. The Agreement ends on the last day of the agreed Membership term, and the Member is not entitled to terminate the Agreement earlier.
- 2. Article II 1 B of the General Terms and Conditions shall not apply to these Special Terms and Conditions.

### ARTICLE III - MEMBERSHIP FEE

- 1. Yearly Promo Student Membership > The Membership Fee amounts to **EUR 234,00**.
- 2. The billing period for Yearly Promo Student Membership is 12 (twelve) months. The Membership Fee for the entire billing period for Yearly Promo Student Membership is payable upon execution of the Agreement

# ARTICLE IV - TERMINATION OF MEMBERSHIP IN THE CLUB, SUSPENSION OF MEMBERSHIP

- 1. In the event of termination of the Agreement by the Company with immediate effect pursuant to Article III 10 of the General Terms and Conditions and its subsequent renewal pursuant to Article III 10 of the General Terms and Conditions, these Special Terms and Conditions shall not apply to the renewed Agreement.
- 2. A Member may suspend the Membership pursuant to Article III 11 and 13-14 of the General Terms and Conditions, provided that the Agreement may be suspended only once and for a maximum period of 1 (one) month. The Membership will be extended by the respective period of suspension on the terms set out in these Special Terms and Conditions.

# **ARTICLE V - FINAL PROVISIONS**

- 1. These Special Terms and Conditions are valid and effective as of 15 October 2025 and apply to all Agreements for Yearly Promo Student Membership concluded from 1 October 2025 to 15 November 2025.
- 2. These Special Terms and Conditions are available on the Company's website, at the Club's premises and on request at the Company's registered office.
- 3. Any invalidity or lack of effect of any provision of these Special Terms and Conditions will not prejudice the validity and effect of the remaining provisions.
- 4. Mutual rights and obligations of the Parties are governed by the laws of the Republic of Croatia.
